## Changes to Global Grant Procedures for 2017-2018 Revised 02/10/17

## 2017-2018 Schedule for Global Grant Applications:

- 1. Your Global Grant requests after July1, 2017 must be submitted by October15 to be considered with others, as a group, on November 13. We want to avoid allowing a large grant from claiming an inordinately large piece of the available funds, without giving due consideration to funding all the grants in the group.
- 2. Your District will allocate at least \$10,000 to each grant reviewed on 11/13 (as long as funds last) to insure all grants will have adequate funds to qualify as a Global Grant. The District will distribute any remaining funds, up to the amount requested, on a pro rata basis to those applications that were under-funded after the initial \$10,000 allocation. Any District Designated funds available after this additional award will be made available for new Global Grant applications throughout the rest of the year, awarded on a first come first served basis, as usual. The following table is an example of how the pro rata basis would work.

(Assume \$45,000 in available DDF for Global Grants)

3. District 6290 will set aside \$7,500 each year from the Global Grant allocation to fund Global Scholars. If there are no Global Scholars in a given year, the fund would accumulate from year to year, up to \$15,000. Acceptance or rejection of a Global Scholar application would, in part, be determined by the funds available in this allocated fund. At the end of each year, when the TRF committee considers whether to give left over DDF to Polio or to Peace Scholars, we will also consider giving additional money to the GS fund.

## 2017-2018 change in the wording of the \$100 *per capita* giving requirement for clubs to qualify for matching grant funds from District Designated Funds

To be eligible to receive matching funds from 6290 DDF, your club must have given at least \$100 per capita to the Annual Fund of the Rotary Foundation in the previous Rotary year. If your club has not met this threshold it cannot receive matching funds from DDF, but you can apply for Global Grants. You will have access to the .5:1 match from the World Fund, matching the club cash in the grant application. Your per capita calculation will be made using the previous July 1 membership records with Rotary International for the year in question.
